ABOUT OMU-YÖS...

- International Student Entrance Examination (OMU-YÖS) is an examination which can be taken by international students wishing to study in Ondokuz Mayıs University (OMU) of Turkey. OMU-YÖS results can be used in the application process for admission to OMU and 97 other universities
- OMU-YÖS 2015 applications will be online and candidates will be able to apply in Turkish, English, or Russian
- OMU-YÖS 2015 exam will take place in exam centers located in Turkey and other countries on a fully controlled, face to face basis and will be in 6 languages: Turkish, Arabic, English, French, German or Russian.
- The examination will be held in one sitting at 17 May 2015 at 10:00 a.m. (Eastern European Time, UTC \pm 2).
- OMU-YÖS 2015 results are valid for a period of two years.

WHO CAN APPLY?

On condition of being a final year high school student or being a high school graduate;

- a) Foreign nationals
- b) Those who are Turkish citizens by birth but cease to be a citizen of Turkey with the permission of the Ministry of Internal Affairs; and the under aged children of such people who are registered in their parent's document of alienage and can certify that they have the "Certificate Regarding the Exercise of Rights Given by Law" which is obtained in accordance with the Turkish Nationality Law
- c) Those who were foreign nationals by birth and acquired Turkish citizenship afterwards; and dual citizens who comply with these criteria
- d)(1)- Turkish nationals who have been continuing their secondary education in a foreign country before 01.02.2013 and have completed the last three years of their secondary education (high school) in a foreign country other than Turkish Republic of Northern Cyprus (TRNC), (including the ones who have completed their secondary education (high school) in Turkish schools opened by the permission of Ministry of National Education which are located in foreign countries other than the TRNC).
- (2)- Turkish nationals who have started their secondary education in a foreign country after 01.02.2013 and have completed their entire secondary education (high school) in a foreign country other than Turkish Republic of Northern Cyprus (TRNC), (including the ones who have completed their secondary education (high school) in Turkish schools opened by the permission of Ministry of National Education which are

located in foreign countries other than the TRNC).

e) TRNC nationals who reside in TRNC and have completed their secondary education in TRNC and have the GCE AL exam scores; and those who are TRNC nationals registered and educated in colleges and high schools in other countries between 2005 - 2010 and who have or will have GCE AL exam scores.

WHO CANNOT APPLY?

- Those who are Turkish Citizens and have completed their entire secondary education in Turkey or T.R.N.C. (Turkish Republic of Northern Cyprus).
- Those who are T.R.N.C. Citizens (except those who have completed their entire secondary education in T.R.N.C. high schools and have the GCEAL test score and those who have registered in a college or high school in other countries between 2005 2010 and received education in these schools and have or will have the GCEAL test score).
- Those who have dual nationalities and their first nationality is Turkish by birth as defined in the sub clause (b), Paragraph 5, Clause 5 (except those who have completed their entire secondary education in a foreign country other than the T.R.N.C. / those who have completed their entire secondary education in a Turkish school in a foreign country other than the T.R.N.C.).
- Those who have dual nationalities and either of them is T.R.N.C. (except those who have completed their entire secondary education in T.R.N.C. high schools and have the GCEAL test score and those who have registered in a college or high school in other countries between 2005 2010 and received education in these schools and have or will have the GCEAL test score).
- Those who are Turkish citizens and have studied in schools within the body of embassies in Turkey or those who are Turkish citizens or who have dual nationalities and their first nationality is Turkish by birth as defined in the sub clause (b), Paragraph 5, Clause 5 and have studied in one of the foreign high schools located in Turkey.

HOW CAN YOU APPLY?

Applications will be accepted starting 05 January 2015

Online pre-registration and exact registration processes will be carried out online through http://yos.omu.edu.tr within the specified time period for applications.

Candidates who have completed the pre-registration procedures will be able to carry out the exact registration procedures on http://yos.omu.edu.tr using the user name and password

that were sent to their email addresses.

Candidates are required to upload a front face photograph in "jpeg" format which easily identifies the person. The photograph should be taken within the last three (3) months.

Payment of the exam fee: Exam fee is 180TL and can be paid either by credit card through the online application or via bank transfer (Candidates who wish to make their payments through bank transfer are required to deliver the transfer receipt to the Coordinating Office by fax or email).

At the final stage of the registration process, the application of the candidate is confirmed by the OMU-YÖS 2015 online system administrator. Candidates who have completed the exact registration procedures can check their registrations in the webpage.

Only online applications are accepted for the OMU-YÖS 2015; other forms of application will not be accepted.

WHEN WILL THE EXAM ENTRANCE CERTIFICATE BE SENT?

The "Exam Entrance Certificate" which includes the language of the exam, address and contact information of the exam centre will be sent to eligible applicants by email one week after the deadline for applications.

Please do not forget to bring your "Exam Entrance Certificate" and passport information to the exam centre!

How are The Exam Results Evaluated?



OMÜ-YÖS 2015 Exam will be evaluated in three separate categories: Basic Learning Skills, Mathematics, and Equal Weight. Number of false answers will not affect the total number of correct answers.

QUESTIONS

• Can I apply without a passport?

Candidates may apply with an identification number. But please bear in mind that a passport is mandatory for going abroad. You cannot enter another country without a passport.

• Can I change the exam centre?

The exam centre cannot be changed after the deadline.

LEGAL ISSUES

The candidates are responsible for the accuracy of the information they provide during the online registration for the OMU-YÖS 2015 exam. False declarations, false pretences, actions against the exam rules and such behavior result in the disqualification of the exam result and legal and administrative action will be initiated.
